There was a rigorous debate about whether this was the time to be considering a shift in policy (regardless of the state ACCESS grant's requirements), given the need for all of our schools to attract any and all applicants. There was also an opinion voiced that our schools should serve all students, not just students from families from economically disadvantaged homes. The Board decided to satisfy the requirements of the grant while holding onto the belief that KIPP NC school should be free and open to all by adopting a policy of holding a weighted lottery prior to the general lottery so that a set number of seats could be reserved for EDS families in each lottery.
